 - a) Comprehensive overview of NESPAK's currently active projects in Punjab and Khyber Pakhtunkhwa, including sector-wise distribution, project status, timelines, and key deliverables.
 - b) Summary of NESPAK's ongoing assignments outside Pakistan, highlighting countries of operation, project scope, strategic significance, and expected outcomes.
 - c) Analytical comparison of NESPAK's payroll structure with comparable public and private sector engineering consultancy firms, identifying gaps, competitiveness, and retention implications.
 - d) Current position of sanctioned posts versus filled positions, critical skill shortages, recruitment pipeline, and measures being undertaken to expedite hiring and strengthen human resource capacity.

 - d) Complete details of the auction process for new teams, bid submissions, and evaluation/ approval mechanism; franchise valuation/ bid price, tenure, fee structure and payment schedule, including revenue-sharing arrangements; and the projected financial model of the two new franchises, including expected revenues, costs, and projected ROI over the next five (05) years.
 - e) Financial implications of expanding to eight (08) teams for existing franchises and for PCB's overall PSL revenue model.
 - f) Audited financial performance and profitability of PCB for the last five (05) years.
 - g) PCB's plan for improvement/ rehabilitation of stadiums and allied facilities, including Karachi, Hyderabad, Peshawar, Faisalabad and Quetta.
 - h) Status of new stadium construction at Islamabad, including feasibility, scope, timelines, funding arrangements and procurement framework.
 - i) An on-site visit by the Honorable Members of Gaddafi Stadium, Lahore, to review current condition, ongoing works (if any), future upgrade plans and operational readiness.
