A meeting of the Senate Standing Committee on **Housing and Works** will be held on **Wednesday, the 29<sup>th</sup> April, 2026, at 11 a.m. in Old PIPS Hall (PRC Hall), Parliament Lodges, Islamabad.** In case of Senate Session in the morning, the meeting will be held at 2:30 p.m. in the afternoon.

- (2) Alleged illegal allotment of Plot No.366 [corner plot of 40x80 (14-Marla)] in Sector D-12/3, Islamabad to Mr. Irfan Nawaz Memon, Deputy Commissioner, Islamabad in violation of the applicable laws/rules and merit-based policies raising doubts on the transparency in the functions of FGEHA in allotment matters.
- (3) Briefing by the Chairman CDA, Ministries of Interior, Planning and Finance on following projects of the former Pak PWD (discussed in various meetings of the Committee):
  - (I) Current status of the 5 lifts of Shaheed-e-Millat Secretariat and the latest position of replacement and repair works including the issue of allocation of funds by the concerned Ministries
  - (II) Latest situation of the construction works of Islamabad Model Jail, expected date of completion of the project and the issue of release of funds by the concerned Ministries.
- (4) **Current status** of litigation, ownership and possession in respect of the 38 kanals of land comprising of Constantia Lodge, Kashmir Point, Murree.
- (5) The Secretary, M/o.
