REVISED NOTICE

Reference Senate Secretariat's meeting notice of even number dated 4th May, 2026. A meeting of Senate Standing Committee on Petroleum will be held on **Monday, 11th May, 2026 at 02:00 p.m. at Old PIPS Hall, Parliament Lodges, Islamabad.** (In case of Senate session in the evening, the meeting will be held at 11:00 a.m. on the same date and venue). The **revised agenda** before the Committee meeting would be as under: -

- i). Briefing on current stock position of Crude Oil, Petrol and Diesel (days cover and MT), current LNG and LPG stocks at EVTL and SSGCL, depletion timeline and domestic gas supply status along with accountability for shortages and time bound plan to ensure uninterrupted supply.
- ii). Despite gas production at Badar Gas Field (PEL), District Ghotki and Qadirpur Gas Field (OGDCL), local residents within the prescribed radius remain deprived of gas facilities, amounting to prima facie non-compliance with binding Supreme Court directions and violation of fundamental rights.
- iii). Detailed briefing by Secretary Petroleum on the composition of PMDC Board of Directors and the criteria of the selection of Managing Director's appointment, its tenure, and the selection process adopted. Details of the start of the appointment process for the new Managing Director, if any.
- iv). Implementation status of paras Nos. 11 & 12 of minutes of Committee meeting held 30th December, 2025 at PSO Headquarters, Karachi concerning the re-examination of the cases of Mr. Ghalib Jalees, former Acting CEO, and Mr. Muhammad Jaffer Mehdi, GM, Sales & Marketing, SSGC LPG Ltd.
- v). Briefing by the Petroleum Division on the suspension of CNG supply in Khyber Pakhtunkhwa, its economic, legal and energy implications and steps taken by the Petroleum Division to ensure uninterrupted gas availability to the sector in accordance with Article 158.
- vi). Failure of Price Differential Claims (PDC) payments to OMCs, fixing responsibility for violations of committed timelines, immediate clearance, and future mechanism by the Petroleum Division to prevent supply disruption.
- vii). Comprehensive briefing by the MD, PARCO on Multan LPG Bowser blast including details of fatalities, disabilities, property, and livestock losses along with compensation, rehabilitation measures and preventive safeguards.
- viii). Detailed briefing by Secretary Petroleum on the Performance of Board of SSGC, LPG Ltd (SLL) and reason for non-election/reconstitution of Board since 2019.
- ix). Any other item with the permission of the Chair.
