Senator Muhammad Tallal Badar, Minister of State for Interior and Narcotics Control, on behalf of **Senator Syed Mohsin Raza Naqvi**, Minister for Interior and Narcotics Control, moved under Rule 263 of the Rules of Procedure and Conduct of Business in the Senate, 2012, that the requirement of sub-rule (2) of Rule 145 of the said Rules regarding notice period for moving of resolution for extension of the Islamabad Capital Territory Local Government (Amendment) Ordinance, 2026 (Ordinance No. II of 2026) be dispensed with.

The Motion was put to the House and Adopted.

RESOLUTION FOR EXTENSION OF ORDINANCE

2. Senator Muhammad Tallal Badar, Minister of State for Interior and Narcotics Control, on behalf of **Senator Syed Mohsin Raza Naqvi**, Minister for Interior and Narcotics Control, moved the following Resolution:-

“That the Senate resolves to extend the Islamabad Capital Territory Local Government (Amendment) Ordinance, 2026 (Ordinance No. II of 2026), for a further period of one hundred and twenty days with effect from

9th May, 2026, under proviso to sub-paragraph (ii) of paragraph (a) of clause (2) of Article 89 of the Constitution of the Islamic Republic of Pakistan.”

The Resolution was passed unanimously by the House.
