- ii) To review and discuss the Federal Government's expenditure on social and digital media campaigns, including transparency, allocation criteria, and comparative spending patterns between digital and legacy media platforms.
- iii) To discuss the recent layoffs and downsizing in various media organizations and their impact on journalists, media workers, press freedom, and the sustainability of Pakistan's media industry.
- iv) To seek an explanation from the relevant Censor Board authorities regarding certification granted to the recently released film titled "Buleha", particularly in view of concerns that the title reflects and invokes the revered Sufi poet Bulleh Shah, who is widely regarded as a symbol of peace, love, tolerance, and humanity.
- v) The Committee may discuss whether the use of such a title for a film reportedly depicting violence, use of weapons, and criminality could distort the historical and spiritual image associated with Bulleh Shah and mislead younger generations. The committee may also deliberate whether the title should be reconsidered in the larger cultural and societal interest.
- vi) To obtain details from Pakistan Television Corporation/ PTV News regarding, The total number of contractual employees presently engaged, their designations, salary structures, and contractual terms. The process and criteria adopted for such appointments.
- vii) To discuss the petition sent by residents of PTV colony Islamabad.
- viii) Any other agenda item with the permission of the Chair.
