 - b) Whether it is also a fact that the Chairman, Evacuee Trust Property Board has declared these transfers invalid in April, 2021 under Article 143 of the Constitution and that decision has been upheld by the Secretary, Ministry of Religious Affairs and Inter-Faith Harmony, if so, the details thereof;
 - c) Whether it is fact that despite the decisions by the Chairman of the said Board and the Secretary of the Ministry, the ownership of the Federal Government of those lands has not been restored in the Revenue record of the Punjab Province, if so, the reason thereof and;
 - d) Whether any action has been taken against those officials who misapplied the said Act of the Punjab Government upon the Federal Government owned lands, if so, the details thereof?
 - vi) Any other agenda with the permission of the Chair.
