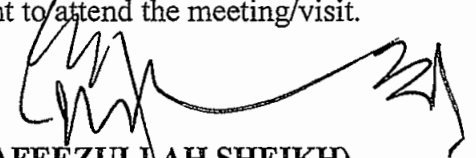
NOTICE
