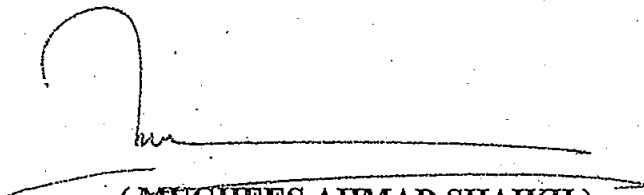

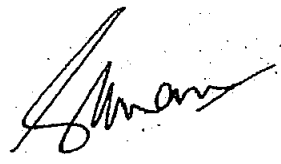

4. The Committee took up Starred Question No.13 asked by Senator Zeeshan Khanzada in the Senate sitting held on 16th January, 2026. The Committee observed that the mover had not attended the meeting to press the question. It was noted that under standard operating procedures, items are typically disposed of after consecutive absences; however, in this instance, the mover did not attend the meeting despite notice due to his prevailing party policy. Consequently, the Committee determined that rather than allowing the matter to linger indefinitely, it was appropriate to dispose of the matter immediately. The Committee accordingly disposed of the Starred Question and directed that a report to that effect be sent to the floor of the House for information as required under the rules.
