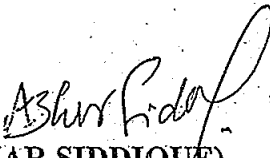
submit a detailed report explaining the absence of the Vice Chancellor, who was also instructed to ensure attendance at committee meetings in the future.
