- ii. Further detailed briefing by Chairman, Capital Development Authority (CDA) on the current position of Katchi Abadi residents, findings of the fresh survey, details of business activities, and the proposed relocation plan. Briefing by the Ministry of Interior on the outcome of Cabinet deliberations on the matter. Specific briefing on the proposed operation and rehabilitation plan for Bari Imam Katchi Abadi.
- iii. The Parliamentary Caucus on Minorities will review the management, maintenance, and security of non-Muslim places of worship in Islamabad. Chairman, Capital Development Authority (CDA) will submit details on Saidpur Village religious sites, Gurdwara and Dharamshala, and the Rawal Dam graveyard. The Chairman, Capital Development Authority (CDA) will brief on budget provisions for maintenance, while Islamabad Police will update on security arrangements. The Committee will also discuss community grievances and measures to ensure equal facilitation for all minority religious sites.

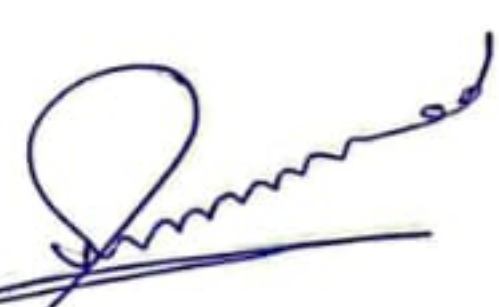
