 - c) Complete list of land, buildings and other assets under the Club's possession or management, including their legal status, present utilization, encroachments, unauthorized occupation and measures taken to safeguard public property.
 - d) In depth details of income generated from membership fees, restaurants, guest rooms, sports facilities, events and other commercial activities during the last three years, together with their operating costs and profitability.
 - e) Details of disciplinary proceedings, inquiries, litigation and complaints involving the Club, its management or employees during the last three years, along with their present status.
- v) Briefing by Secretary Establishment on the following:
 - a) What is the current mechanism available with the Establishment Division to detect dual nationality of government servants in cases where the officer has not submitted a declaration or has submitted a false declaration?
 - b) Details of complaints and disciplinary action taken during the last three years against government servants for the unauthorized, excessive, or improper use of social media and other forms of electronic, print, or digital media, in violation of the applicable conduct rules; along with the names, designations, departments, nature of violations, and penalties imposed. The Establishment Division may also provide a complete list of government servants who sought permission to appear on or use social media, television programmes, podcasts, YouTube channels, or any other media platform, indicating whether such permission was granted, refused, or remains pending.

c) Details of the measures taken or proposed to establish a centralized, real-time mechanism for identifying and monitoring vacancies across all Ministries, Divisions, Departments, and attached organizations, instead of relying on manually solicited updates from individual government entities.

vi) **Briefing by the Chairman, FPSC and Establishment Division on the following:**

a) Current status of the proposed increase in age limit and number of attempts, as recommended by the Senate sub-committee in its report.

b) Progress on the departmental promotion exam, in light of the judgement rendered by the Federal Service Tribunal (FST) on February 24, 2026 in appeals #194, 195, 1172 to 1180(P)/CS/2022.

c) Why does Establishment Division not timely confirm the available vacancies to FPSC for completing the allocation process? Any improvements made?

d) Why are the results of CSS delayed and why does it take more than a year to publish the results?
