- (vii) Number of Courts and Tribunal, lying vacant due to non-appointment of Presiding Officers and reasons for non-appointment of presiding Officers of Courts and Tribunals.
- (viii) Number of cases pending in each Court and Tribunal.
- (ix) Rate of monthly disposal of cases by Courts and Tribunals.
- (x) Necessity of a creating new Courts/Tribunals and/or their abolition due to shortage of pending cases before them.

- II. Further consideration of **"The Juvenile Justice System (Amendment) Bill, 2026"** introduced by Senator Sarmad Ali, in the Senate sitting held on 18th May, 2026.
- III. Consideration of **"The Family Courts (Amendment) Bill, 2026"**, introduced by Senator Samina Mumtaz Zehri, in the Senate sitting held on 24th August, 2026.
- IV. Consideration of **"The Pakistan Psychological Council Bill, 2025"** introduced by Senator Kamran Murtaza, in the Senate sitting held on 1st December, 2025.
- V. Ministry of Law and Justice to present report on increase of salaries, allowances of law officers including Assistant Attorney Generals, Deputy Attorney Generals and report on Disparity in the Salaries, allowances and other prerequisites provided to Law Officers of the Federation and Provinces.
