Briefing by the Chairman, Evacuee Trust Property Board (ETPB), regarding the legal status, protection, conservation and restoration of minority religious heritage sites in Multan, including Prahadpuri Temple, Suraj Kund, Gurukul, Budhla Sant and Jain Temple, and also current status of all the properties attached to all religious, charitable and educational trusts, as per section 2(d) of the Evacuee Trust Properties (Management and Disposal) Act, 1975.
- ii. Detailed briefing by the Secretary, Services & General Administration Department (S&GAD) / Human Rights & Minorities Affairs Department Punjab on implementation of the 5% minority quota in BPS-1 to BPS-16, covering total sanctioned strength, minority employees' data, post/grade-wise filled and vacant quota positions, recruitment procedure, and reasons for non-filling along with compliance measures.
- v. Further briefing by the Inspector General of Police, Punjab regarding the kidnapping case of Kiran D/o Nasir Jamil under the Police Station of Nishtar Colony, Lahore including its current status and progress made so far.

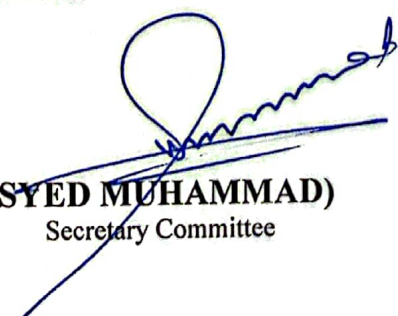
