- (v) mechanism for implementation of recommendations/reports of the Commission by the Executive and the Parliament;
- (vi) Management and utilization of the Access to Justice Development Fund, including:
 - a. receipts, allocations, and expenditure under various heads prescribed in sections 6-A and 6-B of the Law and Justice Commission Ordinance, 1979;
 - b. province-wise and sector-wise utilization of funds

II. Any other matter with permission of the Chair.
