REVISED NOTICE

Reference this Secretariat's Notice of even number dated 8th September, 2026, the meetings of the Senate Standing Committee on Cabinet Secretariat scheduled to be held on 16th, 17th and 18th September, 2026 at the same venue are hereby revised. The meeting scheduled for 16th September, 2026 will be held at 2:00 p.m. as scheduled, while the meeting scheduled for 17th September, 2026 will be held at 11:00 a.m. instead of 2:00 p.m. However, the meeting scheduled for 18th September, 2026 has been postponed.

2. The **agenda** before the Committee would be as under: -

Day One on 16th September, 2026 (Wednesday) at Sindh Secretariat, Karachi

- i) Briefing by the Chairman, OGRA; Secretary, Petroleum Division; and Managing Directors of PSO, OGDCL, PPL and PARCO on outstanding regulatory, financial, operational and policy-related issues confronting the petroleum sector, including matters pending with OGRA and other government organizations, and the proposed measures and timelines for their resolution.
- ii) Briefing by the Chairman/Chief Executive Officer of Chevron Pakistan Lubricants (Private) Limited (Caltex) on the key regulatory, operational and commercial challenges confronting Pakistan's petroleum sector, particularly matters pending with OGRA and other government organizations, and the company's recommendations for their time-bound resolution.
- iii) Briefing by the Chairman OGRA and the Managing Directors/Chief Executives of Sui Southern Gas Company Limited (SSGC), Sui Northern Gas Company Limited (SNGPL) Pakistan Petroleum Limited (PPL), Oil and Gas Development Company Limited (OGDCL), Pak-Arab Refinery Company Limited (PARCO), and Synergy Group regarding the existing policy, criteria and mechanism for the import, indigenous production, allocation, distribution and supply of Liquefied Petroleum Gas (LPG) across different regions of the country, particularly with reference to the availability, allocation, distribution and supply of LPG in the northern regions of Pakistan, including the basis for determining regional quotas and ensuring adequate and uninterrupted supply to consumers..
- iv) **Briefing by the Chairman, OGRA, and MD of SSGC and SNGPL on the following:**
 - a) Why is the reinstallation of a meter removed by the gas companies on default of payment by a consumer, treated as a new connection?
 - b) Reasons for continued accumulation of gas sector circular debt despite repeated tariff revisions by OGRA, specific mechanisms adopted by OGRA (including treatment of prior-year shortfalls, RLNG costs, late payment surcharges, and surplus adjustments) to prevent further build-up of circular debt.
 - c) Year-wise comparison of actual UFG versus OGRA benchmarks, volumes/costs claimed by the utilities, amounts allowed or disallowed by OGRA, and the portion ultimately recovered from consumers through tariffs.
 - d) Complete details of RLNG volumes diverted to the domestic and commercial sectors during the last five years (preferably season-wise or month-wise where available), resultant annual financial cost, subsidy claimed by the utilities, subsidy actually released by the Government, and outstanding recoverable amount.
 - e) Number of pending new connection applications with SNGPL and SSGC, categorised by type (domestic, commercial, industrial), including applicants who have already paid demand notices or urgent fees, average processing time and main reasons for delays.

Day 2 on 17th September, 2026 (Thursday) at Sindh Secretariat, Karachi

- i) **Briefing by the Chairman, Cannabis Control and Regulatory Authority (CCRA), on the following:**
 - a) Authority's present operational status and future plans for developing and regulating Pakistan's medicinal and industrial cannabis sector.

- b) Progress made since the establishment of CCRA, including the status of its Board, staffing, budget, offices, laboratories, rules and licensing system.
 - c) The Authority's three- and five-year strategic plan, with year-wise targets for cultivation, processing, investment, employment, exports and government revenue.
 - d) Licensing criteria and timelines for cultivation, research, seed production, processing, manufacturing and export, along with the number and status of applications received to date.
 - e) Criteria for selecting cultivation areas, fixing permissible acreage and approving cannabis or industrial-hemp seed varieties, including the prescribed THC limits.
 - f) Proposed seed-to-sale digital tracking system and other safeguards to prevent illegal cultivation, diversion, misuse of licences and entry of cannabis into the illicit market.
 - g) Plans for developing testing laboratories, quality standards, pharmaceutical research and industrial uses of cannabis and hemp, in coordination with DRAP, ANF, provincial governments, research institutions and the private sector.
 - h) Major legal, administrative and technical challenges faced by CCRA and a time-bound roadmap for making the regulated cannabis industry fully operational.
- ii) **Briefing by the Chairman, National Seed Development and Regulatory Authority (NSDRA), on the present condition of Pakistan's seed sector and its plans for ensuring the availability of affordable, certified and high-quality seed to farmers, particularly covering:**
- a. Progress made since the establishment of NSDRA, including its organizational structure, staffing, budget, regulatory framework and implementation of the National Seed Policy.
 - b. Crop-wise and province-wise demand, production and availability of certified seed, particularly for wheat, cotton, rice, maize, pulses, oilseeds and vegetables, together with the existing shortfall.
 - c. The Authority's three- and five-year plan to increase certified-seed coverage and develop high-yielding, climate-resilient, drought-, heat-, flood- and pest-resistant varieties.
 - d. Measures to simplify and expedite variety registration, seed certification and import approvals, including current and proposed processing timelines.
 - e. Mechanisms for monitoring seed companies, importers and dealers and taking action against counterfeit, adulterated, mislabeled and substandard seed.
 - f. Plans for digital certification and QR-based seed verification, strengthening testing laboratories and enabling farmers to verify seed variety, producer, germination rate and certification status.
 - g. Strategy for reducing dependence on imported seed, promoting domestic research and seed production, protecting farmers' and plant breeders' rights and increasing Pakistan's seed exports.
- iii) Joint briefing by CCRA and NSDRA on their respective roles regarding cannabis and industrial-hemp seeds, including variety approval, import, certification, testing, multiplication and distribution, and submission of a coordinated, time-bound plan to avoid overlapping jurisdiction and regulatory delays.
- iv) **Briefing by the Managing Director NESPAK on the following:**
- a. Progress on current physical and financial progress of the K-IV project, including revised PC-I status reason for cost escalation and revised completion timelines.
 - b. Current physical and financial progress of the common corridor with KRBT 2.7 km from NIPA to Hassan Square and reason for delay in completion timeline.
 - c. Provision of a complete list of all pending/ongoing NESPAK projects in Sindh, followed by project-wise reasons for delay and remedial actions for their timely completion.
- v) **Any other item with the permission of the Chair.**
