The Senate of Pakistan met in the Senate Hall (Parliament House) Islamabad, at thirty eight minutes past four in the evening with Mr. Chairman (Syed Nayyer Hussain Bokhari) in the Chair.

### Recitation from the Holy Quran

جناب چیئر مین: بسم اللہ الرحمن الرحیم۔ آج ہم سینیٹ کے اجلاس کا آغاز عمرودہ ماحول میں کر رہے ہیں۔ جو سانحہ پشاور میں ہوا، ساری قوم اس پر عمرودہ ہے۔ مختلف parliamentary leaders کی حکومت اور Prime Minister sahib سے ملاقاتیں ہونیں، ان کو پیش نظر رکھتے ہوئے آج Business Advisory Committee میں یہ فیصلہ ہوا کہ آج ہم جس اجلاس کا آغاز کرنے لگے ہیں، ان شہداء اور معصوم کلیوں کے لیے اور ان کے خاندانوں کے غم میں شریک ہونے کے لیے آج باضابطہ اجلاس کی proceedings نہیں چلائیں گے بلکہ دونوں جانب سے متفقہ resolution آئے گا اور دعائے مغفرت تک محدود رہیں گے۔ یہ ان عمرودہ خاندانوں کے ساتھ یکجہتی کا اظہار ہے۔ یہ ان کے غم میں برابر کے شریک ہونے کا موقع ہے۔ ہم دل کی گہرائیوں سے ان کی مغفرت کے لیے دعا مانگتے ہیں اور یہ بھی دعا ہے کہ رب العزت ان کے لواحقین کو صبر جمیل عطا فرمائے اور ان کو ہمت دے کہ وہ یہ صدمہ برداشت کر سکیں۔ یہ پوری قوم کے لیے صدمہ ہے اور اس کے لیے جتنا بھی یکجہتی کا مظاہرہ کیا جائے کم ہے لیکن اس کے لیے عملی اقدامات کی بے حد ضرورت ہے۔ قوم اس بات کی توقع رکھتی ہے کہ مؤثر اقدامات کیے جائیں گے کیونکہ ان حالات میں پاکستان نہ ترقی کر سکتا ہے اور نہ ہی پیش رفت کر سکتا ہے۔ 1۔ Item No. ضروری ہے، میں اس کو take up کرتا ہوں۔

## **Motion Under Rule 263 Moved By Senator Dr. Abdul Qayyum Soomro to Dispense the Rules**

بِسْمِ اللّٰهِ الرَّحْمٰنِ الرَّحِیْمِ۔  
Senator Dr. Abdul Qayyum Soomro: I beg to move under rule 263 of the Rules of Procedure and Conduct of Business in the Senate, 2012, to dispense with the requirements of rule 41 regarding question hour and rules 25, 26, 29, 30 and 133, read with Rule 218, of the said rules in order to enable the House to discuss the incident of attack by terrorists on Army Public School in Peshawar. I also add here assassination of Senator Dr. Khalid Mehmood Soomro.

Mr. Chairman: Thank you. It has been moved that under rule 263 of the Rules of Procedure and Conduct of Business in the Senate, 2012, to dispense with the requirements of rule 41 regarding question hour and rules 25, 26, 29, 30 and 133, read with rule 218, of the said rules be dispensed with in order to enable the House to pass a resolution and discuss the incident of attack by terrorists on Army Public School in Peshawar.

## **Fateha for the Victims of Peshawar Incident**

Mr. Chairman: Before proceeding for the resolution

**Resolution Moved by Senator Mian Raza  
Rabbani in Condemnation of Peshawar Incident**

Senator Mian Raza Rabbani: Sir, the Senate of Pakistan resolves as under:

Declares the willful, inhuman, barbaric and gruesome murder of innocent school children on December 16, 2014, the responsibility for which has already been claimed by the TTP, as most barbaric, atrocious, inhumane, horrifying and shocking.

Declares the Peshawar incident of 16th Dec. 2014, to be a grave national tragedy. Believes that the assault is in fact an attack on the State and Society of Pakistan and its future.

Recalls that, in the past also the TTP and other banned militant organizations have targeted civilians, armed forces, police, law enforcing agencies and intelligence agencies. In Peshawar they targeted the future of the country by seeking to instill fear, to prevent children from seeking education.

Condemns this brutal, monstrous and willful murder of our youth.

States that this attack will not weaken the resolve of the nation to fight the militants to the finish. If anything it has strengthened in national resolve to fight to the TTP, the militants and their sympathizers and apologists. Expresses abhorrence of all those who by acting wittingly or unwittingly, as apologists of the militants for misleading the nation and weakening its resolve.

Calls upon the people to unite in this hour of national grief and mourning.

Calls upon all the stakeholders and the people to be conceptually clear and implement in letter and spirit the vision of Pakistan as articulated by the Quaid-i-Azam Mohammad Ali Jinnah in his August 11th 1947 address.

Recognizes that the militants are posing existential threat to Pakistan and therefore there is need for ideological and strategic clarity and complete unity.

Reaffirms that, the antithesis of terrorism, sectarianism and religious extremism is strong, viable and delivering democracy functioning under the Constitution of 1973.

Expresses its profound grief, sorrow and dismay over the Peshawar incident.

Extends its deepest sympathies to the families of the bereaved in the Peshawar incident of 16th Dec. 2014, and the Federation stands by them in their this hour of grief.

Resolves to destroy the TTP and the militants to preserve, protect and defend the Pakistani way of life till the last drop of our blood.

Mr. Chairman: I now put the resolution before the Hosue.

*(The resolution was adopted unanimously)*

Mr. Chairman: Before we adjourn the House, I would like to inform the honourable members that the motions under rules have been submitted in the Secretariat regarding this incident. The regular debate would be taken up from Monday onward. The honourable members who would like to express their views are requested to furnish their names to the Secretary so that we can proceed and discuss this inhuman incident which has taken place at Peshawar.

I now adjourn the House to meet again on Monday, 21st December, 2014 at 3:00 PM.
