### “QUESTIONS FOR ORAL ANSWERS AND THEIR REPLIES”

*to be asked at a sitting of the Senate to be held on*

@80. \***Mst. Afia Zia:** (Notice received on 19-10-2009 at 14:20:p.m.)

*Will the Minister for Foreign Affairs be pleased to state the steps taken by the Government for repatriation of Dr. Aafia Siddiqui?*

**Makhdoom Shah Mehmood Qureshi:** According to Dr. Aafia’s family, she allegedly went missing in March 2003 from Karachi. She was found in Afghanistan after her arrest by Afghan Police on 17 July 2008. She was transferred to U.S.A. in August 2008 for prosecution purpose. Government of Pakistan has paid US\$2 million as fee for hiring services of three (03) lawyers to defend her case in the local court of New York. The Court in New York will hold trial on 11 January 2010. The team of Defence attorneys have filed certain motions in the court on behalf of Dr. Aafia Siddiqui.

2. The Embassy has sent several note verbales to the Department of State (October 16 and 31, 2008, November 18 and 24, 2008, January 26, 2009, February 17, 2009, May 12 and 21, 2009 and June 12, 2009) requesting for withdrawing charges and repatriation to Pakistan on humanitarian grounds and also because of her deteriorating mental condition.

3. The Ambassador in his meetings with the US Attorney General Michael B. Mukasey on 17 November 2008, Assistant Secretary Richard Boucher on 24 November 2008 and Director, FBI, Robert S. Muller on 18 December 2008 requested for Ms. Siddiqui’s repatriation to Pakistan. The Ambassador made similar requests in his meetings with Deputy Secretary James Steinberg in the Department of State on 23 February 2009 and the US Attorney General Eric Holder on 23 April 2009 in Obama Administration.

4. Embassy has worked with the concerned authorities to ensure that she is fairly treated. On Embassy’s intercession her brother M.A. Siddiqui was granted permission to meet his sister during her confinement at Carswell Hospital, Texas. Ms. Siddiqui has been calling on telephone her family (brother, mother, sister), receiving proper medical treatment, and Halal food etc.

5. Once, the U.S authorities declared Aafia Siddiqui was fit to stand trial, the Embassy on the recommendation of Ms. Siddiqui’s family engaged a team of attorneys Linda Moreno, Charles Swift and Elaine Sharp for defense of Ms. Siddiqui. In her meeting with the Ambassador at Carswell Hospital, Texas on June 9, 2009, Ms. Siddiqui agreed not to oppose their appointments.

6. Judge Berman of New York City Court who will be supervising the trial, held a court hearing in the subject case on November 19, 2009. Ms. Aafia Siddiqui also attended the court proceedings. The court heard a number of motions filed by defense attorneys.

7. The U.S. Judge, granted defense attorney's permission to take two depositions in Afghanistan (One defence attorney appointed by the GOP and one provided by the Government of the US to defend Aafia Siddiqui to record the evidence from witnesses). This according to defense attorneys is a rare victory. In the light of the decision of the court, prosecution and defense attorneys would visit Afghanistan.

8. In response to one of the defense's motion lodged by Attorneys, the U.S. Government has conceded that Ms. Siddiqui's statement which was recorded by the FBI from the time to time when she was under custody, will not come on the government's case, because it was obtained illegally by the FBI.

9. As expected by the defense attorneys, the motions to dismiss the charges based on jurisdictional grounds was dismissed by the Judge.

10. The next motions deadline is December 14, 2009, (*i.e.* limitation imposed on the US government to file any witness or evidence against Dr. Aafia Siddiqui). These motions are critical as it will determine what evidence will come in at trial, beyond Aafia Siddiqui's statements.

11. On the insistence of the Embassy, the defense attorneys continue to work for arranging a video monitoring set-up so that Ms. Siddiqui can watch the proceedings from her cell, and not have to go through the strip-searches each time she is forced to come to the court. They are working with the Bureau of Prisons to get this in place prior to her trial.

12. The trial date is scheduled for January 19, 2010. The status conference was heard by the court on January 11, 2010, wherein discussions were held with attorneys of both sides to decide the pre-trial evidentiary issues.

*Will the Minister for Special Initiatives be pleased to refer to the Senate starred question No. 105, replied on 8th October, 2009 and state the district-wise location of water filtration plants installed in Balochistan?*

**Mr. Lal Muhammad Khan:** The Clean Drinking Water programme comprises two projects, *i.e.* Clean Drinking Water Initiative (CDWI) Project and Clean Drinking Water for All (CDWA) project. Whereas, CDWI Project 2004 envisaged installation of one water filtration plant in each Tehsil, the CDWA Project 2006 envisages installation of one plant in each Union Council. So far 102 plants and 319 plants have been installed in Balochistan under these two projects, respectively. District-wise lists are at Annex-A and B, respectively.

134. **\*Mst. Afia Zia:** (Notice received on 17-10-2009 at 10:10:a.m.)

*Will the Minister for Special Initiatives be pleased to state:*

- (a) *the duration after which the water filtration plants installed by the Government are cleaned; and*
- (b) *the criteria adopted to check proper functioning of these plants?*

**Mr. Lal Muhammad Khan:** (a) UF Membrane, Activated Carbon Filter and Sand Filter are the components of water filtration plant, which require regular cleaning and service.

These filters are cleaned twice a day by the inbuilt auto-backwashing system.

The raw water tank is cleaned manually on monthly basis.

(b) The Operation and Maintenance of the water filtration plants is to be carried by the contracting firm for 3 years after their installation, alongwith signal based central monitoring system. This system shall check / monitor proper functioning of installed water filtration plants. The signals emanating from this system shall provide the following informations:

- Operational / Non-operational status of plants.
- Backwashing time and duration.
- Hourly water flow rate.

The water quality is to be checked through sample testing. The contractor is required to submit water quality test reports from reputed laboratory on monthly basis.

**Makhdoom Shahabuddin:** During the last five years, the Ministry of Health has not received aid from any foreign donor for prevention and control of Hepatitis and Cancer in the country. For control of Malaria, the Directorate of Malaria Control has received financial assistant only from Global Fund for AIDS, TB and Malaria (GFATM) as per following details:

**Makhdoom Shahabuddin:** (a) There are total number of 2232 sanctioned posts of nurses in the Federal Govt. Hospitals in the country. Their province-wise break up is at Annex-I. These include 150 posts of SKBZH, Quetta which are not yet filled-in.

(b) There are a total number of 1930 Nurses working against the said posts with province wise break up at Annex-II.

(b) The Government is taking a number of steps to increase gainful employment opportunities and balance the distribution of doctors between urban and rural areas of Pakistan. Some key initiatives are:

- (i) Development and planning of a Human Resource for Health strategy (HRH strategy) to growing challenges of staff retention, recruitment, distribution, attrition, career development, and satisfying work environment.



- (ii) The new Health Policy envisages that development of the Essential Health Services Package will lead to more efficient, effective and integrated delivery of health services and human resource management including creating enhanced employment opportunities for doctors.
- (iii) The Health Policy also envisions a greater role of public-private partnerships in increasing employment opportunities and balanced redistribution of doctors in areas of greatest need; and
- (iv) Shifting towards a more proactive and expedited recruitment process for hiring of doctors for primary and secondary level health facilities will also increase employment opportunities and reduce the number of unemployed doctors in the country.

143. **\*Mr. Muhammad Hamayun Khan:** (Notice received on 25-11-2009 at 08:57:a.m.)

*Will the Minister for Foreign Affairs be pleased to state:*

- (a) *the number of Pakistanis in Indian Jails who have completed their tenure of punishment imprisonment; and*
- (b) *the steps taken by the Government for their release?*

**Makhdoom Shah Mehmood Qureshi:** (a) According to information available, there are 79 Pakistani prisoners in Indian Jails who have completed their prison sentence.

(b) The Government of Pakistan regularly raises the issue of repatriation of all Pakistani prisoners including fishermen in Indian jails. This is a humanitarian issue and remains a high priority for this Ministry. The issue is followed up at the following levels:

- (i) Efforts by the High Commission of Pakistan in New Delhi:

As soon as this Ministry receives any information regarding a Pakistani prisoner in Indian jail, our High Commission in New Delhi is directed to approach the Indian authorities for provision of Consular access. Once Consular access is provided to our nationals by the Indian authorities, we request the Ministry of Interior to confirm the national status of the prisoner. Upon confirmation of the national status, our High Commission in New Delhi issues travel documents and approaches the Indian authorities for early release/repatriation of the prisoner. Indian authorities take their own time to respond and repatriate a Pakistani prisoner.

- (ii) Pakistan — India Judicial Committee

A Judicial Committee on Prisoners was established in 2007 to ensure humane treatment of prisoners in both countries and their expeditious release.

The Judicial Committee was able to influence both Governments to release prisoners who had completed their sentences or who were arrested for minor offences. These efforts resulted in the release of 108 Pakistani and 238 Indian prisoners including fishermen in 2008.

The Government of Pakistan has proposed revival of the Judicial Committee to the Indian side. The Indian side has not responded to our proposal so far.

(iii) Consular Access Agreement

During the visit of Indian External Affairs Minister to Islamabad on 21 May 2008, Pakistan and India signed the Agreement on Consular Access. The Agreement seeks to ensure humane treatment of nationals of either country arrested, detained, or imprisoned in the other country.

However, the Consular Access Agreement is not being implemented by India in letter and spirit.

**Mir Hazar Khan Bijarani:** (a) Details of month wise prices of cars during the financial year 2008-2009 alongwith horse power is given at Annex- .

(b) Prices of cars/automobiles are governed by the market mechanism. Government has no control on any price fixation. Government provides Policy frame work including tariff and non-tariff policy measures.

(c) Prices are based on market mechanism. Government has abolished 5% Federal Excise Duty (FED) in budget 2009-10, prices were decreased, details are given at Annex-B. Declining exchange rate of Pak rupee is also one of the factors of price increase. However, Ministry of Industries and Production is in constant consultation with the local manufacturers to reduce prices.

**Makhdoom Shahabuddin:** (a) The purpose/objective for setting up of Central Research Fund was to provide funds for Research and Development in drugs, as provided under clause (b) of Sub-section (1) of Section 12 of the Drugs Act, 1976 read with rule 3 of the Drugs (Research) Rules, 1978, which entails the scope of utilization of this fund as under:

*“The Federal Government may utilize the Fund for conducting research, development or evaluation of a drug either itself or through a research institution working under its control or disburse it among investigators or institutions for such purposes subject to such conditions as may be specified and for that matter, it may also utilize the fund to upgrade and establish Drugs Research and testing laboratories and a unit in the Drugs Control Section, Ministry of Health, for evaluation and monitoring of the research proposals and projects and management of the fund”*

(b) The amount deposited in the said fund since its establishment and as reconciled on 30th June 2009 is Rs.643.428 million.

*Will the Minister for Special Initiatives be pleased to refer to the Senate starred question No. 105, replied on 8th October, 2009 and state the location of water filtration plants installed in Bahawalpur, Rahim Yar Khan and Bahawalnagar district so far?*

**Mr. Lal Muhammad Khan:** (a) Under Phase-I of Clean Drinking Water Programme titled “Clean Drinking Water Initiative (CDWI) project”, **14** water filtration plants have been installed in Tehsils of Districts Rahim Yar Khan, Bahawalpur and Bahawalnagar. District-wise list of plants so far installed is annexed (Annexure-A).

Phase-II of the Clean Drinking Water programme, currently under implementation as “Clean Drinking Water for All (CDWA) Project”, envisages installation of one water filtration plant in each Union Council of the country. Accordingly, **347** water filtration plants are to be installed in Districts Rahim Yar Khan, Bahawalnagar and Bahawalpur. List containing district-wise locations for installation of water filtration plants is annexed (Annexure-B).

The executing agency in respect of installation of water filtration plants in Punjab Province is Local Government Department of the Punjab. The contract has been awarded and a

few demo plants, have been installed for replication after their inspection and approval. In addition, one plant each has been installed at Rahim Yar Khan and Bahawal Pur. Thus the process of installation of water filtration plants in Punjab has commenced and is likely to take off soon.
