(*Def.*) *Question No. 10 **Senator Mushtaq Ahmed:** (Notice Received on 22/12/2022 at 9:23 AM) QID: 40001

Will the Minister for Interior be pleased to state:

- (a) whether it is a fact that the files of many houses located in the I-10 sector, specially those located in street No. 99, I-10/4, are missing for many years, if so, the details consisting of the house Nos., names of the owners as well as the time since those files are missing;
- (b) the number of applications/complaints received for recovery of those missing files indicating also the names of the complainants and dates of the applications; and
- (c) the disciplinary action taken against those who are responsible behind the disappearance of those files indicating also the date by which those files be recovered?

Rana Sana Ullah Khan: (a) Total No's of plot files in street No. 99 Sector I-10/1 are 48, out of which only one plot file of house No. 622 St No. 99, Sector I-10/4 which was allotted to Mst Shamim Akhter W/o Abdul Aziz being Affecttee of Village Ropper, and further transferred in the name of Mr. Masood ul Rauf S/o Malik Fazal dad Khan and further Transferred in name of Mr. Safdar Zaman Kiani S/o Raja Lehrasab Khan

and further transferred in the name of Rashida Begum & 04 others through legal Heirship.

- (b) Only one application complaint dated 05-05-2021 received in this Office from Zahid Safdar Kiyani & Others regarding issuance of No Demand Certificate and case file was found Missing.
- (c) The subject File has been Re-Contructed an inquiry against officials / officers concerned has been initiated / forwarded to the Security Directorate accordingly. (copy attached)
- (*Def.*) *Question No. 53 **Senator Fawzia Arshad:** (Notice Received on 26/12/2022 at 3:18 PM) QID: 40238

Will the Minister for Interior be pleased to state:

- (a) whether it is fact that the employees of the Social Security Institution Islamabad have been on contract since its establishment in 2013, if so, reasons thereof;
- (b) whether it is also a fact that these employees are not being paid perks like other Federal Government employees, if so, reasons thereof; and
- (c) the time by which the said employees will be regularized?

Rana Sana Ullah Khan: (a) It is fact that the employees of the Social Security Institution, Islamabad have been on the contract since its establishment in 2013. The reasons thereof are as under;

- (i) At the time of its establishment, the mother organization (PESSI) did not allocated due share in assets/manpower. To start with its function, the manpower was engaged on short term basis to meet with the emergency that is treatment of secured workers.
- (ii) The service regulations were finalized with the approval of the competent forum *i.e.* Governing Body. Some of the staff members filed writ petition against the service regulations in Islamabad High Court which is still pending in the honorable court. Therefore the recruitment process could not be finalized/completed.

- (b) Such employees have been paid all perks as per their entitlement.
- (c) The service regulations were revised on the request of staff members which are at the final stage of approval by the competent forum. As soon as service regulations are approved, the recruitment process will be started.

Will the Minister for Information and Broadcasting be pleased to state:

- (a) the qualification, experience and age limit for the appointment of the Chief Information Commissioner and Commissioners of the Pakistan Information Commission (PIC);
- (b) the perks, privileges and other benefits being drawn by the Chief Information Commissioner and Commissioners of the Commission;
- (c) the budget allocated and utilized by the Commission during the last three years with year wise break up;
- (d) the total number of cases pending in the Commission, disposal rate, causes for delay and steps being taken for expeditious disposal of the cases; and
- (e) whether it is fact that majority of the appeals pending in the Commission are lodged by habitual litigants, if so, the details and the steps being taken to discourage this trend?
- **Ms. Marriyum Aurangzeb:** (a) The appointment of the Chief Information Commissioner and Commissioners of the Pakistan Information Commission (PIC) are made in line with Section 18(3), (4) & (5) of the Right of Access to Information Act, 2017 which states:
- (3) The Information Commission shall comprise of three Commissioners to be appointed by the Prime Minister, with following composition: namely:

- (a) One member shall be qualified to be a judge of the High Court;
- (b) One member who has been in service of Pakistan in BS-22 or equivalent;
- (c) One member shall be from civil society having a degree based on sixteen years of education from recognized institution and experience of not less than fifteen years in the field of social sciences; and
- (d) The information commissioners shall be of less than 65 years of age at the time of appointment".
- (4) The Information Commission shall be headed by the Chief Information Commissioner, who shall be appointed by the Prime Minister from amongst the Commissioners.
- (5) The Chief Information Commissioner and the Commissioners shall hold office for a term of four years from the date on which they assume charge of their office and shall not be eligible for re-appointment. (Annex-I).
- (b) The perks, privileges and other benefits being drawn by the Chief Information Commissioner and Commissioners are equal to Management Position Scale: (Annex-I)
 - i. Chief Information Commissioner = MP-I
 - ii. Commissioners= MP-II
- (c) The budget allocated and utilized by the Commission during the last three years with years wise break up;

- (i) the prevention or detection of crime;
- (ii) the apprehension or prosecution of offenders;
- (iii) the administration of justice;
- (iv) the operation of the immigration controls excluding exit control list (ECL);
- (v) the maintenance of security and good order in prisons or in other institutions where persons are lawfully detained; and
- (vi) any civil proceedings which are brought by or on behalf of a public body or arise out of an investigation conducted; and
- (k) the exemptions set out in section 16 shall cease to apply after every twenty years and that record of public bodies shall be made public.
- 17. Appeal.—(1) An applicant who is not satisfied by decision of the designated official or where no decision has been communicated to him within the time fixed for such decision, he may, within a period not exceeding thirty days after either receiving a decision or after the time-limit for such a decision has passed, prefer an appeal to the Information Commission.
 - (2) An appeal under sub-section (1) shall be free of charge.
- (3) The Information Commission established under section 18 shall decide an appeal under sub-section (1) within a period of sixty days.
- (4) The public body shall, in an appeal under sub-section (1), bear the burden of proof of showing that it acted in accordance with the provisions of this Act.
- 18. Information Commission.—(1) Within six months of the commencement of this Act, the Prime Minister shall establish Pakistan Commission on Access to Information to be known as the Information Commission.
- (2) The Information Commission shall enjoy operational and administrative autonomy, except as specifically provided for by this Act.
- (3) The Information Commission shall comprise three Commissioners to be appointed by the Prime Minister, with the following composition; namely:-
 - (a) one member shall be from amongst the persons qualified to be a Judge of a High Court;
 - (b) one member who has been in the service of Pakistan in BS-22 or equivaler t; and

- ij
 - (c) one member shall be from civil society having a degree based on sixteen years of education from a recognized institution and experience of not less than fifteen years in the field of social sciences;
- (4) No person shall be considered for appointment as Commissioner under sub-section (3) unless he is less than sixty-five years of age at the time of such appointment.
- (5) The Information Commission shall be headed by the Chief Information Commissioner, who shall be appointed by the Prime Minister from amongst the Commissioners.
- (6) The Chief Information Commissioner and the Commissioners shall hold office for a term of four years from the date on which they assume charge of their office and shall not be eligible for such reappointment.
- (7) The Chief Information Commissioner and the Commissioners shall not hold any other public office or be connected with any political party at the time of or during their appointment in the Information Commission and, once appointed, they shall work on full time basis and may not run any business or pursue any profession during their tenure as the Chief Information Commissioner and Commissioners.
- (8) The Chief Information Commissioner and Commissioners shall be removed if there are serious complaints of mental and physical incapacity and misconduct against them, which are materially inconsistent with the status of being Chief Information Commissioner or, as the case may be, a Commissioner. The complaint shall be lodged before a five-member Parliamentary Committee comprising two Senators nominated by the Chairman Senate and three Members of National Assembly nominated by the Speaker National Assembly. The Speaker National Assembly shall nominate one of the five members as the Chairperson of the said Parliamentary Committee:

Provided that where the National Assembly stands dissolved the Parliamentary Committee shall comprise five Senators and the Chairman Senate shall nominate one of the five Senators as Chairperson of the Parliamentary Committee.

- (9) The Parliamentary Committee shall consider the complaint record reasons and present its recommendations to the Prime Minister who shall implement the recommendations within thirty days from the date of receipt of such recommendations.
- Functions of the Information Commission.—(1) The Information Commission shall have the primary responsibility to receive and decide on appeals under section 17.

Will the Minister for Interior be pleased to state the measures / steps taken by the ICT police to minimize the increasing incidents of theft, mobile snatching and street crimes?

Rana Sana Ullah Khan: It is submitted that the ICT Police has taken the following steps to control crime, theft, mobile snatching and street crimes as well as protection of general public:

- 1. Identification of Crime pockets.
- 2. Crime cluster Analysis.
- 3. Data Base (survey of Kachi Abadies)
- 4. Intelligence Based Policing.
- 5. Combing/Search Operations.
- 6. Random checking of Guest Houses/Hotel/Motel.
- 7. Survey of Rented Accommodation, illegal settlements. Surveillance of suspected Elements.
- 8. Data proofing of released prisoners
- 9. Monitoring through Safe City cameras.

- 10. Establishment of Eagle Squad consisting of 260 motorcycles including 1114 Police officers/officials has been established within Islamabad on the pattern of Dolphin Force in Punjab to control street crimes. It is also added that the ratio of street crimes has been considerably decreased after the establishment of Eagle Squad. It is further mentioned that the robbery, dacoity, gangs have been busted.
- 11. Patrolling has been enhanced in the crime areas.

Will the Minister for Information and Broadcasting be pleased to state whether it is a fact that PEMRA had directed the Media through its notification not to report the F-9 Rape Case of an innocent girl on gun point, if so, reasons thereof?

Ms. Marriyum Aurangzeb: PEMRA is mandated to enlarge the choices available to the people of Pakistan through proliferation of electronic media, in news, current affairs, religious knowledge, art and culture as well as science and technology.

Clause-8(5) (6) of Electronic Media (Programme and Advertisement) Code of Conduct, 2015, explicitly states that while covering accident, violence and crime including unfortunate incidents of rape, PEMRA licensees shall be extremely cautious and ensure that identity of the victim shall not be revealed without the permission of the victim or victim's guardian, where victim is a minor.

The same is reproduced as under:

"8. Coverage of incidents of accidents, violence and crime:—

- (5) Extreme caution shall be exercised in handling themes, plots or scenes that depicts sex offence and violence, including rape and other sexual assaults.
- (6) Identity of any victim of rape, sexual abuse, terrorism or kidnapping or such victim's family shall not be revealed without prior permission of the victim or victim's guardian where victim is a minor."

PEMRA prohibited broadcast/rebroadcast of the horrific incident of Rape in F-9 Park, Islamabad, *vide* Prohibition Order dated 05-02-2023, under Section 27(a) of PEMRA Ordinance, 2002 as amended by PEMRA (Amendment) Act, 2007 **on the request of the victim herself** *i.e.* **Ms. Maryam Saleem** (copy of the request letter is attached at Annex-I). The above referred provision of PEMRA Law, is reproduced below for a ready reference:

- "27. Prohibition of broadcast media or distribution service operation:—The Authority shall by order in writing, giving reasons therefore, prohibit any broadcast media or distribution service operator from—
 - (a) broadcasting or re-broadcasting or distributing any programme or advertisement if it is of the opinion that such particular programme or advertisement is against the ideology of Pakistan or is likely to create hatred among the people or is prejudicial to the maintenance of law and order or is likely to disturb public peace and tranquility or endangers national security or is pornographic, obscene or vulgar or is offensive to the commonly accepted standards of decency.
