Rana Tanveer Hussain: (a) There are **45** regular Lecturers (BS-17) and **18** Daily Waged Staff working in evening shifts in Islamabad Model Colleges.

(b) The regular Lecturers (BS-17) (Government Employees) working in evening shift in Islamabad Model Colleges are being paid salaries as per provisions of Government Pay and Packages whereas, daily wages Staff working in evening shift in Islamabad Model Colleges are being paid remuneration as per provision of Federal Government amounting to Rs. 25,000 per month.

Mr. Bilawal Bhutto Zardari: Mr. Sair Khan, while posted as Cypher Assistant in Embassy of Pakistan, Stockholm, Sweden, was involved in issuance of visas to Afghan nationals in violation of government guidelines. He was immediately recalled from the Mission and the matter was referred to FIA for investigation and appropriate action.

Mr. Abdul Qadir Patel: (a) PIMS

The autism service is operational for the past six months after inauguration by Honorable Minister of Health. The service offer daily OPD, diagnosis, analysis and management plan. Speech Therapist, Psychiatrist, Physiotherapist, Pediatrician, Audiology services are readily available.

(b) A PC-I is being prepared for a comprehensive services.

(a) **NIRM**

However, NIRM is providing psychological and speech therapy assessment, diagnosis and management of children with autism spectrum disorder (ASD).

The patients are given treatment by following ways:-

- (a) Diagnosis and psychological assessment
- (b) Behavioral interventions.

- (c) Parents/family support and counseling.
- (d) Coordination and school consultation to understand unique needs of ASD children.
- (e) For behavioral issues Psychiatrist prescribes medicines and the Speech Therapy department plays its role for development of speech and communication skills of the patients.
- (b) As above.

Mr. Ehsaan-ur-Rehman Mazari: (a) There is a PHF Women's Council Comprising of 12 members elected by their respective Provincial Women's Hockey Associations.

In compliance with the Instructions contained in IOC Charter as also stipulated in the POA Constitution of PHF Women's Wing has been provided to the PHF Female Hockey in Pakistan which establishes functions PHF Women's Wing:-

(a) Women representatives elected by the respective Provincial Women Hockey Associations, shall be as per the following distribution:-

And the rest shall be entitled to only 02 representations each within their respective provincial Associations. The Women's Council elects its own Chairperson, Vice Chairperson and Honorary Secretary

The vehicles are being used by MoFA's general pool, Camp Offices and SECDIV Division.

- (b) No vehicle held in the Ministry's pool is attached with any officer for security duty.
- (c) No officer in the Ministry, availing monetization is using official vehicle. There are 83 officers who availed monetization during the said period.

- (b) whether the work on the said project has been started alongwith the expected date of completion?

Mr. Abdul Qadir Patel: (a) Yes, the Project of extension of Federal Government Polyclinic (Jinnah Hospital at G-11/3, Islamabad) is included in the PSDP of the current financial year. The said project was approved by CDWP on 29th November, 2021 at a total cost of Rs. 9,913.730.

The Infrastructure Development Authority of Punjab (IDAP) Lahore is the executing agency for the said project with project life of 3 years (36 months). IDAP further awarded the construction work to the China Civil Engineering Construction Corporation (CCECC). Letters of Acceptance (LoA) were issued by IDAP and after completion of all codal

designing / planning requirements, the Letter of Commencement (LoC) is expected within this month.

An Amount of Rs. 1300.00 million has been released to IDAP till-date, whereas remaining allocation of Rs. 1200 million is under process.

(b) The Infrastructure Development Authority of Punjab (IDAP) Lahore arranged ground breaking of the said project on 21-03-2022 and after processing of international tendering work has been awarded to a Chinese contractor (CCECC-Salman Joint Venture (LoA Issued, LoC will be issued soon)) and they have conveyed project duration of this turn-key work within the approved time frame *i.e.* 913 days (2.5 years) from date of commencement. The site teams, equipment and material have been mobilized by the contractor and work is expected to be undertaken at full pace after LoC, shortly.

Will the Minister for National Health Services, Regulations and Coordination be pleased to state the measures being taken by the Government for preventing monkey pox virus in Islamabad Capital Territory?

Mr. Abdul Qadir Patel: The Federal Ministry of National Health Services, Regulations and Coordination along with NCOC, NIH, vigilantly monitoring the situation while keeping all the relevant stakeholders on board for ensuring preparedness, timely response, and containment of Monkey pox cases in Pakistan. In this regards, following measures have been taken by the Ministry in Islamabad Capital Territory:

- NIH with Ministry of NHSR&C is constantly in liaison with Border Health Services (BHS) and district health authorities (DHO & CDA) to ensure surveillance through laboratory diagnostics, contact tracing, rapid identification of suspected cases, and to provide care and isolate cases to prevent transmission.
- Established close liaison with IHR Regional Office EMRO and all concerned countries.
- NIH/MNHSRC developed and disseminated Mpox guidelines, for airports and hospitals.
- Multiple inter-ministerial and inter-sectoral meetings conducted to take all stakeholders onboard for enhance coordination and to prepare for preparedness response.
- NIH issued Advisory on Mpox in 2022.
- NIH has conducted capacity building workshops among health care providers and laboratory personnel for early detection, confirmation and management of Mpox in ICT.
- Activated screening of passengers on all international airports in coordination with Border Health Services.

- Mechanism and facilities for quarantine and isolation of suspected travelers has been established.
- NIH has initiated free of cost testing for Mpox suspected cases.
- Streamlined mechanism for sample collection and testing at NIH and selected provincial public health labs.
- Developed information, education & communication (IEC) material for general public.
- The Seasonal Awareness & Alert Letter (SAAL) and Advisory on Prevention and Control of Mpox has been widely disseminated and made available at NIH website: www.nih.org.pk.

Will the Minister for Federal Education, Professional Training, National Heritage and Culture be pleased to state whether it is a fact that future of the Professors in Public Sector Universities is at risk due to funds revision policy issued by HEC, if so, steps taken by the Government to protect their due interest?

Rana Tanveer Hussain:

- (i) The Federal government grant is distributed among all the federally funded universities in accordance with provisions of the HEC funding policy approved by the Commission in 2009 with no revisions so far.
- (ii) Besides the annual recurring grant, HEC also provides its partial funding contribution to universities against the faculty appointed under Tenure Track System (TTS a market-competitive structure for faculty) on top of the BPS salary. As per policy, which is applicable across the country, the HEC contribution to salary of each TTS faculty member policy is calculated at a volume over and above the BPS salary of the corresponding grade prescribed by the respective

Governments (Federal and Provincial). The said revision has been made to standardize the HEC's contribution in TTS funds across country and to eliminate the variance in BPS salary of among the universities driven from (i) variance in BPS of the Federal and provincial Governments, and/or (ii) additional allowances granted beyond Government's BPS by the universities. However, this standardization / revision has no adverse effects on the faculty members.

- (iii) The higher education sector, during the last five years, has witnessed tremendous growth in terms of establishment of new universities / HEIs in the federal and provinces, increase in students' enrolment and appointment of the new faculty and staff. Also, considerable increase in inflation and 100% raises in the salaries and pension during this period have increased expenditure side of the universities/HEIs at unprecedented level.
- (iv) Contrary to the unprecedented increase in expenditure side, federal government's grant to universities is stagnant since 2017-18 at the level of Rs.65.00 billion, where except for Govt. of Sindh no provincial government is providing recurring grant to their universities.
- (v) It is important to highlight that universities are autonomous bodies and governed through their statutory authorities (Finance & Planning Committee, Syndicate/BoG, and Senate). The salary related matters of universities' employees (faculty and staff) are internally administered in accordance with approved prescribed rules/regulations of the universities and their budgetary provisions.
- (vi) Nonetheless, funding (HEC share) against the existing faculty members for (i) monthly pay (ii) annual increment (iii) gratuity, and (iv) impact on promotion, is duly intact. There is no risk to the future of faculty members. Moreover, the rights [interests] of faculty members (**Employees**) is an internal administrative matter of the universities (**Employers**).

Mr. Abdul Qadir Patel: (a) As per Sr. No. iii of the Decisions / Conclusion of approved PSDP minutes review meeting 2022-23, held on 19th June, 2023, chaired by the Secretary Ministry of NHSR&C "Executive Director, PIMS shall make concrete efforts to ensure successful installation, Commissioning / Inspection of the MRI by the 14th August, 2023 without further delays, MRI will be inaugurated on 6th September, 2023" copy of minutes enclosed at Annex-A.

(b) The project is not reflected in PSDP 2023-24, no funds have been allocated for purchase of MRI machine during the current financial year 2023-24. However, this Institute has requested for allocation of additional funds amounting to Rs. 55.725 million to meet the shortfall occurred due to foreign exchange fluctuation and imposition of GST.

Proceeding of the meeting

- The meeting starts with the recitation of the Holly Quran, the chair welcomed all the participants. The chair asked DHO-ICT to brief his projects one by one. DHO -ICT presented financial progress of each project in detail. DHO informed that BHU Janggi Saydan has land issue which will be resolve on priority. Further it was noticed that the construction work of all projects facing problems of different nature. Chair directed that PWD may be asked to depute dedicated officers/ engineers to the health-related projects. It was also directed that DHO-ICT may present performance/ updated progress for his projects in a exclusive meeting with pictorial evidences of each project. In this regard, Chair directed that each project will be monitor on site personally by JS (D&C) on monthly basis. A WhatsApp group will be created by DHO to keep updated all the stakeholders of projects.
- 3. Executive Director, PIMS and HoD Radiology, PIMS also briefed their projects. Head of Radiology, PIMS appraised that MRI machine along-with others accessories have been delivered by M/s Seimens Healthcare Pvt Ltd. The chair directed to ED PIMS and HoD Radiology, for its successful installation by the end of July, 2023 and complete Commissioning by the end of 14th August, 2023 without further delays. PIMS management will submit a completion report in August, 2023 and inauguration of the MRI will be made on 06th September, 2023. Chief Engineer, Pak PWD informed about HVAC that 90% progress of HVAC has been completed. In this regard, the Chair directed to Pak PWD for commission /functional of HVAC in July-August, 2023. Executive Director, PIMS briefed the chair that procurement process for the project titled JICA/ MCH & Neurosurgery, PIMS have been successfully completed. However, due to ban on procurement of Plant Machinery, formal purchase orders have been withheld. Joint Secretary



(D&C), M/o NHSR&C appraised the meeting that NOC from Austerity Committee/ Secretary Finance has been processed and outcome of the same is expected shortly. Moreover, the Chair also directed to the management of PIMS, FGPC, NIH, FG TB Centre, RTI etc to provide the detail of complete building space and its utilization along-with covered area and electricity load /bills for last three months for the purpose of solarization of these buildings / offices. An umbrella PC-1 for solarization of all buildings will be prepared by PIMS in consultation with other departments / hospitals. HoD Radiology informed that there is a shortfall of Rs. 50.00 million due to dollar escalation in the project of MRI, PIMS.

- Executive Director FGPC briefed his projects. He mentioned that his projects are on tracks. Chiar directed that JS D&C will visit School Nursing and performance may be reviewed, ED requested that Dr. Farrukh Iqbal, FGPC will be focal person FGPC G-11/3, to be constructed by IDAP. A proposal/ concept note for health tower through Public Private Partnership inconsultation with other hospitals will be prepared by CEO, Schat Sahut Program.
- The projects of Health Services Academy (HSA) were also came under discussion. Dr. Shahzad, VC, HSA mentioned that a revised PC-1 with USAID funds support will be submitted shortly by HSA.
- Joint Secretary, (D&C) briefed the reasons of low utilization of allocated funds. Main causes were ban on procurement of plant & machinery during CFY. Another important cause is lake of procurement experts / personals in the projects / departments. In this regard, the Chair directed that P&D wing of this ministry may make efforts for relaxation on ban with Finance Division & M/o PD&SI. Moreover, to ensure accelerated utilization of PSDP funds and to streamline the procurement procedures in projects/ departments/ hospitals/ institutions, the defunct Central Procurement cell/ committee constituted by this Ministry shall be re-functional with modified composition, TORs & scope immediately.

After detail deliberation, the following decisions were made by the Secretary, M/o NHSR&C.
